You have the right to access and correct any personal information held by the Club. Generally, the Club does not disclose your personal information to other organizations or individuals unless legally required. However, the Club may disclose your information to third parties who provide services under contract, with the condition that these parties maintain the confidentiality and security of your personal information.

Additionally, the Club may use your personal information—including data gathered from your membership card usage in gaming or other club facilities (excluding ATMs)—for marketing purposes. # Card-Based Gaming

## Terms & Conditions

All individuals who play gaming machines at this Club agree to abide by the conditions of gaming machine play and the following rules, which constitute the terms and conditions for using card-based gaming at Laurieton United Services Club & Kew Country Club. If you do not agree to these terms and conditions, you must refrain from playing the gaming machines or utilising the card-based gaming functions. The Club's decision, as expressed by its officers and/or employees regarding the interpretation of these rules, shall be final.

By law, the Club can issue only one player card per person, and individuals must be over 18 to qualify. If your card is lost or stolen, you must report it to the Club immediately. A replacement card will be issued once you have completed the necessary declaration required by the Club. You are not permitted to have more than one player account open at this Club at any time.

The security of funds in player accounts is a shared responsibility between the Club and the account holder. The government and its agencies assume no responsibility for any losses that may occur from the account. The account holder is solely responsible for ensuring that their Personal Identification Number (PIN) remains confidential and that no one else has access to their player card. The account holder is liable for any losses arising from or in connection with their failure to comply with these responsibilities.

The account holder may set a weekly account limit by submitting a written request to the Club. This limit may also involve arrangements for deactivating the account card. If a weekly account limit is established, the player can modify this limit through a written request. Any decrease in the weekly account limit will take effect immediately, while an increase will not take effect until 24 hours after the notice is given to the Club.

By participating in card-based gaming at Laurieton United Services Club & Kew Country Club, you agree to and are bound by these terms and conditions, which may be modified by notices posted on the Club's member notice board.

Monthly player activity statements are available upon request at no charge if the account has been active. A fee may apply for copies of previous activity statements.

You have the option to participate in card-based gaming at either Club at any time. If you choose not to participate, please notify the Club immediately in writing.

Under Section 97 of the Gaming Machines Regulation 2010, individuals issued with a player card have the option to participate in the loyalty scheme operated by the Club. If you do not wish to participate in the player reward scheme at any time, please notify the Club immediately.

The Club assumes no responsibility for any losses incurred by players as a result of playing gaming machines, whether using cash or a membership rewards card. Players acknowledge that certain linked jackpots may be electronically transferred to a winning machine's credit meter.
